## MUCH BIRCH PARISH COUNCIL Minutes of the Parish Council Meeting Held on Thursday 3rd April 2008 in Much Birch Community Hall

## 1. To accept apologies for absence

## 2. Declarations of interest on agenda items

DD & VS declared a prejudicial interest on agenda item 6 and both left the room before item discussion was entered into

### 3. To approve Minutes of previous meeting – 06/03/08

The minutes were agreed and signed by Chairman

At this point, the chairman adjourned the meeting to allow contributions from West Mercia Police, Ward Councillor and members of the public to speak.

The Chairman then re-opened the meeting.

## 4. Clerks report back on action items.

SID- Clerk reported that a meeting will be taking place with HFDC road safety officers and MS& Clerk on Tuesday 8<sup>th</sup> April to agree proposed location sites for SID. Clerk to bring progress report for next meeting.

Footpaths Officer- Clerk reported that another letter had been sent to Mr Anderson requesting him to confirm if he wishes to remain parish footpaths officer or not and if not could he return the footpaths maps of the parish to the clerk a date for reply was given as 24/03/2008 no reply from Mr Anderson has been received.

Clerk reported that information & forms received from HFDC to be attended to with regard to footpaths identified by parishioners for inclusion onto the definitive map.

Lengthsman Work & administration –Clerk reported that the claim for lengthsman grant had been submitted to HFDC total value of claim £956.91 awaiting payment from HFDC.

Lengthsman has carried out identified work since previous meeting apart from weed killing along Tump Lane & cutting of inside of hedge at Tump Lane. This work is to be carried out as soon as weather permits.

Much Birch School Parking problems- Clerk reported that Clive Hall of HFDC Highways Dept would be contacting the Parish Council & school with regard to proposals on the parking issues in due course. Litter at A49- Clerk reported that a letter had been sent to Mr Bobbin of HFDC requesting clearance of litter along the A49 and asked if it would be possible to extend the frequency of litter clearance from this location. Reply from Mr Bobbin has been received and he confirmed that litter clearance is due to be undertaken from Monday 17<sup>th</sup> March for six weeks. He also acknowledged the request for an increase in the frequency of litter clearance, however due to the cost of cleaning trunk roads and health & safety measures along with the traffic management that has to be in place the limited budget would not allow for this.

Clerk reported that invoices had been sent out regarding parish rents to Mr Simms & Mr Enoch.

# 5. To receive report from HFDC Public Rights of way officer Rob Hemblade on condition of Parish Lane.

Mr Hemblade outlined the issues raised on the results of the consultation of parishioners living on Parish Lane as follows

Broadly, Parish Lane can be split into two parts, upper and lower. The lower part is the subject of a planning enforcement matter and he was unable to comment on that aspect. However it is fair to say that it is in a very poor state of repair and needs some work doing on it. If the lane continues to deteriorate to a point it becomes dangerous to pedestrians and horse riders the council may have to look at possibly closing the lane or restricting access.

The top half of the lane is in much better condition but there are still parts that need attention. This would involve some localised surface improvements and tying into any drainage system that may be out in at the lower section. It is not anticipated that any work will be carried out on the upper section until we there is a clearer idea of what is happening along the lower section.

There is an old drainage system which was put in place a number of years but has not operated successfully. Although this will be looked at again, it is unlikely that is can be utilised.

## 6. To consider report on result of Parish Lane consultation.

Clerk read out the report on result of consultation.

Resolved that: The information given by PROW officer at the meeting we would need to wait for report from PROW on the way that they intend to carry this matter forward.
