7.0 Update on speeding and Community Speed Watch

The residents who were present expressed their concerns about the ongoing speeding issues, especially focusing on Tump Lane. PCSO Carol Marsh was in attendance at the meeting. She advised that she had been chasing and chasing the situation for Much Birch and had discovered that the co-ordinator had in fact resigned. A new person was being recruited to the role but there was only one person processing the applications for local CSW efforts. The Chair asked if there was anyone to elevate the concerns about no progress to and PCSO Marsh advised that she would forward any e mails chasing things up. There was a wish to carry out speed watch along Tump Lane and past the bus stop from the school. The question was asked as to where the parish were in terms of progressing the CSW and the Chair advised that the desired locations and the volunteer details had been sent in for consideration. The parish was now awaiting the next steps. It was commented that the proposed new footway for pedestrians along part of Tump Lane may have an impact on traffic going forward. PCSO Marsh would send details of revised contact arrangements for the CSW. The Clerk would send PCSO March dates of the forthcoming parish council meetings.

DESCRIPTION: Increase main roof pitch, the provision of a dormer and roof lights to new bedrooms together with fenestration changes.

APPLICATION TYPE: Full Householder

DESCRIPTION: Proposed demolition of Former Park Hall Ballroom and Erection of 5 Dwellings and 15 Timber Holiday Lodges, reception area and associated works **GRID REF:** OS 349093, 230271 **APPLICATION TYPE:** Planning Permission

The parish council considered the application 222687 and resolved that although some changes to the configuration of houses etc. had been made, there were still "strong objections" to the application and that the main concerns had not been addressed, satisfactorily, in the reconsultation. The original objections would be reiterated via the comments facility.
