1st – 30th November 2021

Witness Appeal

Officers are appealing for information after a single-vehicle collision on the A49 in Harewood End, Herefordshire, where a man sadly died.

Christopher Smith, who was 66, died after the car he was driving hit a wall shortly after 7am on Wednesday 17 November. Ambulance crews and officers from West Mercia Police attended but sadly he was pronounced dead at the scene.

Op Sceptre

The 15th November saw the launch of Operation Sceptre, a week long operation led by the Home Office, to help continue ongoing efforts to tackle knife crime.

We are pleased to say that levels of knife crime in the South Wye are extremely low in comparison to other parts of the country. However, it's vital that we don't become complacent and that we work to help keep these levels low.

The team here have been conducting sweeps of local playing fields and surrounding areas to check that no knives have been secreted by persons looking to use them at a later date (a tactic often used by gangs in more metropolitan areas). We're pleased to report that no knives have been found.

PCSO Hayley Warne and PC Tally Hunt took an active role and took the knife arch to Southwye Police Boxing Academy (Hinton Community Centre) where all members of the club that were training that night walked through to participate in the National Op.

If you have any knowledge or suspicion of a person carrying a knife or bladed article in a public place for anything other than a legitimate reason then please let the team here know, or report your concerns via Crimestoppers.

National Drink, Drugs Campaign

National Police Chiefs Council (NPCC) National Drink / Drug Driving Campaign Wednesday 1st December 2021 to Saturday 1st January 2022.

In line with the National Police Chiefs Council (NPCC) National Drink / Drug Driving Campaign, West Mercia Police will be engaging the Christmas Drink and Drug driving campaign which will run from 00:01hrs on Wednesday 1st December 2021 until 23:59hrs Saturday 1st January 2022 inclusive.

Police Officers will breath test all drivers involved in collisions which they deal with, irrespective of whether or not there is a suspicion of alcohol and where there is a suspicion of drugs

Officers are also encouraged to consider using their powers in relation to drug impaired driving if considered appropriate.



Mini Pc's Brenda and Clive have made their 1st visit to The Cabin Childcare in Much Birch due to traffic issues and concerns raised by parents and members of the public. They will be there for a month and then move on to pastures new.

The mini PC's are available to all schools in the South Wye area for a month at a time. Online Charity Fraud

With Christmas fast approaching, this time of year has traditionally been a popular time to donate online to charity. Unfortunately, as with most areas of life nowadays, the generosity of the public is seen to be an area of potential exploitation by unscrupulous scammers. The warning below appears on the Action Fraud web site at present and serves as a timely reminder to check that you are donating to a genuine charity before handing over any money.

Public urged to donate safely this Christmas as it's revealed £1.6m was lost to online charity fraud over the past year

The Fundraising Regulator, the Charity Commission for England and Wales, National Trading

Standards and Action Fraud are joining forces to call on the public to give safely when donating online. Data from Action Fraud reveals that £1.6m of the public's money was lost to online charity fraud over the past year.

The fraud captured by this data includes requests for donations for non-existent charities and the fraudulent collection of funds from genuine charities. Action Fraud's data shows that the £1.6m loss to fraud is up by 16% on the figure reported in the previous year.

The call for the public to give safely this Christmas is being co-ordinated by the Fundraising Regulator – the body which oversees charitable fundraising in the UK. It is encouraging the public to take steps to protect themselves online, particularly as the nation approaches the festive period, during which appeals for charitable donations increase.

The campaign is urging members of the public to conduct some simple checks before giving to charity, to make sure their donations reach the intended recipient. This includes:

Check the charity name and its registration number on the Charity Commission website to find out whether the charity is legitimate.

Use the Fundraising Regulator's online Directory to find out whether a charity has registered with it and committed to excellent fundraising.

□ Look out for the Fundraising Badge on charity marketing materials – when people see it, they can have confidence in charity's fundraising.

□ Ask questions about the cause – if people are still unsure about giving, they should always ask for more information. Legitimate causes will be happy to respond.

Gerald Oppenheim, Chief Executive of the Fundraising Regulator said:

"The British public is always exceedingly generous when giving to charity, and we want to make sure that they can continue to do so, safe in the knowledge that their donation is going to its intended cause.

"Just a few simple steps – including looking out for the Fundraising Badge, which means a charity has committed to best practice – will help the general public to make informed decisions when donating to good causes, and we are pleased to be working closely with other regulators to deliver this important message."

Pauline Smith, Director of Action Fraud, said:

"Charities work tirelessly all year round to help those in greatest need. Sadly, criminals will try to abuse the generosity and goodwill of others and this can have a huge financial impact on charities and the causes they support. "We would encourage people not to be put off donating to charities, but to follow a few simple steps to ensure your donations don't end up in the wrong hands this Christmas. Make sure you do your research before donating to ensure you're giving your money to a legitimate charity this Christmas.

Mike Andrews, National Co-ordinator at the National Trading Standards eCrime Team, said:

"Online fraudsters are preying on the goodwill of generous people digging deep to give to charitable causes. If you are looking to make a charitable contribution online this festive period, it's important to carry out some checks to ensure your money goes where you intend it to. Follow the advice from the Fundraising Regulator and, before you part with your money, check the website to ensure it is genuine."

Paul Latham, Director of Communications and Policy at the Charity Commission said:

"Many people give very generously at Christmas. By making simple online checks, donors can ensure their hard-earned money reaches genuine registered charities, which are accountable to the Charity Commission and the public for the way they are run, and how they spend their income."

Property Marking

The team continues to offer free security marking of property for anybody who may be interested in an extra deterrent to thieves. This is aimed primarily at things like tools, garden implements, mowers etc and involves us writing an identifiable mark on the item and then spraying it with a lacquer, thereby making it practically impossible to remove. This mark then acts as a deterrent to any potential thief and would also assist police in identifying the rightful owner of any property they may come across that is suspected to have been stolen. If you are interested in having any property marked in this way then please contact us.
