# 7.0 Update on Community Hubs and Jubilee

### **7.1)** Talk Community Hubs

Cllrs Pickering Grey and Goldsmith were looking into objectives for the Community Hub. Cllr Pickering Grey had spoken to delegates from the Community Café. The Community Café delegates were receptive to the idea of a Community Hub. There was some discussion on the role of the Hub which would be to point people in the direction of information, rather than to try to provide advice itself. The remit, roles and frequency of the Hub, also working in conjunction with the Ward Cllr, would be determined and Cllr Cook would discuss possible hall hire arrangements with the Booking Secretary. **DESCRIPTION:** Change of use of land to garden and siting of a bell tent for use as a holiday let **GRID REF:** OS 350080, 232415

DESCRIPTION: Proposed erection of two pairs of semi detached dwellings in place of one pair of semi-detached dwellings and large outbuilding, presently on the site.

APPLICATION TYPE: Outline

**APPLICATION NO & SITE ADDRESS:** Planning Consultation - 220607 – Ash Farm, Tump Lane, Much Birch, Herefordshire, HR2 8HP

**DESCRIPTION:** Variation of condition 6 173052/F (Construction of a farm workers cottage) alter the condition to restrict occupation to an individual who is involved in operating the Green Burial Site rather than an agricultural worker.

**GRID REF:** OS 350131, 230667 **APPLICATION TYPE:** Planning Permission

The Parish Council had no objections to the proposal detailed in planning consultation 220607.

APPLICATION NO & SITE ADDRESS: Planning Consultation - 220981 - Westwinds,

Wrigglebrook Kingsthorne, Hereford, Herefordshire HR2 8AU

**DESCRIPTION:** Proposed changes to roof to continue pitched roof over current flat roof, including re-covering the entire roof. Timber cladding to walls following external wall insulation. Erection of a bike shed in front driveway. **GRID REF:** OS 350396, 231718

APPLICATION TYPE: Full Householder

The Parish Council resolved that there were no objections to the proposals detailed in planning consultation 220981.

# 9.0 Parish Roads and Footpaths

# 9.1) To note any defects to be reported to Balfour Beatty

As previous. To include locked gate onto footpath on PROW LL4 Laskett Lane.

# 9.2) To put forward work for the Lengthsman

The newly refurbished notice board, repaired, repainted and cleaned was back at "Conker Corner" near the bus stop on the school side of the A49.

The Lengthsman had strimmed path MB20 following the previous months request. It was noted that the path was tarmac underneath.

The sign from the bottom of Tump Lane (public house end) had disappeared and there was just a square post standing there. Query as to replacement sign (small directional sign to Much Birch)?

The finger post near property Belle Vue had been re-set.

Sign lying on its side at top of Parish Lane. Cllr Crum to check this.

Cllr Crum would also talk with neighbouring property owners on Barrack Hill regarding keeping ditch clear for drainage.

# 9.3) Footpath Officer - to receive any update or action points

"Herefordshire Trail" path details would be shared with the Footpath Officer. FPO named as contact point.

### 9.4) To receive any update on speeding in Tump Lane

The idea of instigating a Community Speed-watch initiative (subject to suitable view point etc.) would be re-opened with the Police Road Traffic Safety Advisor.
