Open Session:-

The Chair welcomed everyone to the meeting. There were no comments during the Open Session which closed at 7.31 pm.

1.0 Apologies for Absence

There were no apologies for absence.

2.0 Declarations of Interest

There were no declarations of interest made.

3.0 Minutes of previous meeting

The Minutes of the Parish Council Meeting, held at the Much Birch Community Hall on the 4th November 2021, were approved as a true and correct record of the Meeting.

4.0 Reports

4.1) P.C.S.O. from West Mercia Police

Golden Valley Briefing - Newsletter circulated when received.

4.2) Ward Councillor Ward Cllr Toni Fagan updated the meeting regarding issues at path MB6 where the path was reported as being "pretty inaccessible for most of the year - particularly for elderly people". The new Footpath Officer would be keeping a watch on this. The gate had been tied but the gate was now "off." The proposed footpath for Tump Lane was not currently being progressed as the corner of garden required to achieve this was "not available." There were possible hedging issues on the opposite side of the road. School parking for the Much Birch School was now in the local farmyard, by permission. The A49 issues were still a topic of discussion with the Highways Authority and the Police Safety Advisor. A consultation call was booked with the relevant parties to talk about speeding issues and speed enforcement. The issue of traffic overshooting red lights at the A49 crossing at the top of Tump Lane was mentioned, as this had been observed.

The Core Strategy consultation was mentioned as an opportunity for the parish council to feedback on this, if wished. There was a commitment by Herefordshire Council to engage people better in the planning process. The displaying of the "yellow planning notification sign" on location was a part of this process. There were issues with underfunding of enforcement action. Hedgerows had been replanted, at an address in Wormelow, following a protracted delay. Investigation into the unspent 106 monies from planning developments was underway. The money should be spent on infrastructure etc. to support the houses being built.

- **7.2)** Parish land update Two councillors had been to see the developers on site. Notes of the meeting had been circulated to the parish council members and these would form the basis of the understanding for the boundary reinstatement. The notes of the meeting would be formally sent to the contractor, by the Clerk, with a request for acknowledgement of the matters noted.

APPLICATION NO & SITE: Planning Consultation – 214165 and 214166 - Walled Garden Adjacent Stable Cottage, Much Birch, Herefordshire HR2 8HT

The Parish Council discussed the application 214165 and 214166 and determined that there were no objections, but that there should be a comment made that the modifications to the wall should be carried out sympathetically in due regard to the status of the building and the wall.

APPLICATION NO & SITE: Planning Consultation - 214152 - Hill House, Kingsthorne, Hereford, Herefordshire HR2 8HH

The Parish Council discussed the application 214152 and determined that there were no comments.

APPLICATION NO & SITE: Planning Consultation - 214160 - Sarum, Much Birch, Hereford, Herefordshire HR2 8HX

The Parish Council discussed the application 214160 and determined that there were no objections.

9.0 Parish Roads and Footpaths

Some drain clearance had been carried out. The drain cover near to Waterloo Lane was still wobbly and seemingly unsafe.

Clerk would check if any self help gritting round clearance would be taking place by grit spreading, as had previously been the case, around the Barrack Hill area.

Lengthsman grant funding was on schedule for reinstatement, on a matched funding basis. The Lengthsman to carry out seasonal grip and path clearance as required.
