# 8.1) To consider any planning applications

There were no new applications for consideration.

## 9.0 Parish Roads and Footpaths

## 9.1) To note any defects to be reported to Balfour Beatty

Path from shop to Carrot and Wine shop to the pub (Tump Inn) (Much Dewchurch) still remained in a poor condition and drain by the Yew Tree blocked Floodwater lying on the road near the Skippet (off the A49 towards Kingsthorne) – Much Dewchurch Parish (Clerk to e mail MDPC Clerk).

Soil run off issue on Wrigglebrook Lane – this was in the hands of the Environment Agency who had carried out an inspection. Clerk to report mud/silt on road to the Locality Steward as it could be potentially hazardous.

To check with Locality Steward regarding placing a grit bin in the "hammer head" of Tump Lane. There was also a report of heating oil leaking in Upper Wrigglebrook Lane. This was also in the hands of the Environment Agency who were investigating the source of the spill. Water did appear to be dispersing the oil.

In regard to Verge maintenance letter from Balfour Beatty – the PC determined that verges would be cut to preserve visibility splays.

#### 9.2) To put forward work for the Lengthsman

To look at grips, gullies and drains around the parish.

# 9.3) Footpath Officer - to receive any update or action points

Footpath Officer Steve Owen had sent his apologies.

# 10.0 Neighbourhood Plan-update

The meeting closed at 8.13 pm

The Neighbourhood Plan was out for public consultation until 00.00 on 11<sup>th</sup> February 2020. Opportunities to comment had been advertised and copies of the plan placed in public buildings.
