The Chair welcomed everyone to the meeting. There were no comments during the Open Session. The Open Session closed at 7.31 pm.

1.0 Apologies for Absence

There were apologies received from Cllr Veronica Thomas and Footpath Officer Steve Owen.

2.0 Declarations of Interest

3.0 Minutes of previous meeting

3.1) The Minutes of the Parish Council Meeting, held via Zoom on the 4th February 2021, were approved as a true and correct record of the Meeting.

4.1) P.C.S.O. from West Mercia Police

Golden Valley Briefing sent when received.

4.2) Ward Councillor Ward Cllr Toni Fagan advised about matters relating to Herefordshire Council. Herefordshire was being promoted as a "staycation" destination. The Cyber Centre on the Enterprise Zone had been completed. The number of looked after children was coming down. Planning in the north of the county was on hold due to phosphate levels and the River Lugg. There was a lot of negotiation regarding the situation at present.

A considerable amount of local litter picking was taking place around the parish. Biodiversity and bulb planting on the A49 was being encouraged. Proposals were being put forward to Highways England for funding and Verging on Wild were involved. More information could be presented to the PC if desired.

Proposal to lay electric cables across parish land at Barrack Hill

Russell Pryce, Land Agent for the developer building at Barrack Hill next to the parish land at Rosebank was in attendance. He had asked the Parish Council to consider the possibility of laying electrical cables to serve the new homes etc. under the parish land. The proposal would see the cable(s) move from overhead to underground. The Parish Council listened to the proposal and determined that they would talk to the tenant of the parish land and look at the proposals with a view to making a decision. Further information may be sought and the possibility of compensation considered.

APPLICATION TYPE: Permission in principle

Session one of the PC Meeting ended at 8.10 PM and session two commenced at 8.15 PM. The parish councillors, Ward Cllr Fagan and four members of the public were present.

The Parish Council discussed the details of application 210025 and heard representation from local residents. A number of concerns were highlighted and these included access and highway safety plus matters relating to the settlement boundary, as defined in the emerging Neighbourhood Development Plan for Much Birch. It was agreed that the Parish Council would be objecting to the proposal of permission in principle and the draft response would be circulated to the members by the Clerk, for their approval, before submission to the Planning Authority. Ward Cllr Fagan advised that she had requested referral regarding the decision to the Planning Committee.

Potholes were noted on Wrigglebrook/Minster Farm. There were also potholes at the top of Paige's Pitch outside Cyprus Cottage.
