## 8.1) To consider any planning applications and appeals as may be advised

There were two new applications for consideration of comments:

**APPLICATION NO & SITE ADDRESS:** Planning Consultation - 222346 - Land at Eden House,

Eden Lane, Barrack Hill, Little Birch, Herefordshire

**DESCRIPTION:** Outline planning for a detached self build dwelling and garage.

**GRID REF:** OS 350325, 232340 **APPLICATION TYPE:** Outline

The parish council discussed the planning consultation 222346 and resolved to object to the application on the following points:

- 1) Adequacy of parking and turning out onto Eden Lane, including concerns over visibility to do this.
- 2) The inaccurate statement made in the application in regard to the adopted Much Birch Neighbourhood Development Plan (ref. MB1), indicating that the identified requirement for new homes had not been met.
- 3) The impact of the proposed building, and aspect concerns, in an area bordered by open countryside and by woodland (ref MB2).
- 4) The outline of the proposed development, as shown on the application, appears to include a public footpath that is not believed to be within the applicant's ownership.
- 5) The comments and objections made in the Ecology Department's statement have the full endorsement and support of the parish council.

**APPLICATION NO & SITE ADDRESS:** Planning Consultation - 222450 - Much Birch C of E School, Much Birch, Hereford, Herefordshire HR2 8HL

**DESCRIPTION:** Installation of outdoor classroom building, and separate play screens and climbing wall.

**GRID REF:** OS 350096, 230924

**APPLICATION TYPE:** Planning Permission

The parish council discussed the planning consultation 222450 and resolved to support the application.

The Footpath Officer updated the meeting that a lot of the paths were now clear of crops and obstruction. Path MB7 from A49 to Hollybush Lane was overgrown. The second stile on the Hereford Trail had a broken paddle. The Footpath Officer would report this to the PROW Team. There were some possible paths to open up re Tump Lane and the Old Saxon Path.
